

## How much do Turkish Airlines charge for a cancelled flight? (Flight!!Termination!!Fees))

The **cancellation charges for Turkish Airlines** depend on the **type of ticket purchased, route, and timing of the cancellation +1-{800}-(228)-(2760)**.
