NOTICE OF THE 1996 WORK REFORM ACT PASSED BY THE DEMOCRATS

THE 1996 WORK ACT DEFRAUDED THE SOCIAL SECURITY ACT OF 1935 AND THE SSA SSI ACT OF 1975 PASSED BY REPUBLICANS WHICH ALL GAVE SECTION 8 AS A RIGHT AND FINANCIAL ASSISTANCE TO ANY BENEFICIARY WHETHER HE WORKED OR NOT NO MATTER RACE OR RELIGION OR STATUS IN 1996 THIS ASSISTANCE WAS TAKEN FRAUDENTLY BY THAT ACT THE 1996 WORK REFORM ACT PASSED BY THE DEMOCRATS DEFRAUDED THE SSA ACT BECAUSE SSA AN SSA RULES 416.1124 AND RULE 416. 2001 STATE GIVE A MONTHLY CASH ASSISTNCE FROM SOCIAL SERVICES AND SECTION 8 AS A RIGHT IN ALL SOCIAL SERVICES NOTE THAT THIS IS IMPORTANT FOR ANY PERSON IN THE JUDICIARY TO REFERENCE THAT IN THE UNITED STATES CONSTITUTION STATES THAT THE SUPREME RULE OF LAND IS THE CONSTITUTION AND US CODES AND ACTS THEN AND THEN STATE RULES SO THE UNITED STATES CONSTITUTION STATES THAT THE GOVERNMENT HAS A RESPONSIBILITY TO PROVIDE ALL CITIZENS THE RIGHT TO SOCIAL SECURITY THE ALL CITIZENS HAVE A RIGHT TO HAVE SUFFICIENT PLACE TO LIVE AND SUFFICIENT INCOME ESPECIALLY IF THE PERSON CANNOT PROVIDE THIS AND HAS DISABILITIES AND POOR, IN POVERTY OR SENIOR OR IN MY THING I HAVE BEEN OFFERED A JOB IN THE JUDICIARY AND SSA AND SOCIAL SERVICES BUT CANT WORK ALL DAY BECAUSE OF MANY DISABILITIES AND THE BIGGEST IS I CANNOT BE PRIVATE AND WHEN I AM ANYWHERE I AM TREATED LIKE A FAMOUS RAP OR BASKETBALL ICON WITH NO FUNDS MEN ON JOBS DO NOT LIKE ME AS I WAS OFFERED A JOB BY COURT STAFF IN TOWSON MARIA BUT HOW CAN I WORK WITH MEN LIKE THE BAILIFFS WHO DENIED ME THE RIGHT TO PETITION ON MARCH 19TH AND MAY 22ND 2024 SO FROM THAT I HAVE LOW INCOME WANTING AND WORKING FROM MY PLACE FOR THE JUDICIARY WITH NO PAY AND MOST GOVERNMENT AGENCIES WITH NO PAY TELLING SOCIETY HOW TO FILE FOR BENEFITS.

IN CLOSING WITH THIS ELECTION AND PENDING EVICTION I WANT THE WOMEN IN THE COURT AND MEN TO NOW THAT WE CANNOT GET NO BENEFITS IN SOCIAL SERVICES IN THE NATION LESS WE GET MARRIED AND HAVE A FAMILY IN MARYLAND THIS ACT ALSO MADE WOMEN WHO ARE VULNERABLE LEAVE THE RESIDENCE AND WORK A JOB ALL DAY AND NOT TAKE RESPONSIBILITY FOR THEIR FAMILY AND ACCORDING TO RELIGION THEIR APPROPRIATE PLACE IN SOCIETY FOR THE WOMEN IS WEAKER THAN THE MAN THIS ACT MASS INSTITUTIONALIZED MEN AND MADE THEM WITH NO FINANCIAL ASSISTANCE AND CAME FROM INSTITUTIONS MADE AT WOMEN COMING FROM INSTITUTIONS WITH NOTHING AND THIS MADE WOMEN ESPECIALLY COLORED WOMAN TAKE THE RESPONSIBILITY OF LEADER OF THEIR FAMILY ANGRY THAT SHE HAD TO TAKE THAT RESPONSIBILITY AND
