**ORDER FOR MODIFICATION OF SUPPORT**

UPON CONSIDERTION of the Petition for Contempt filed by Plaintiff and Motion for Modification of Support filed by Defendant and any responses thereto, and upon the agreement of the parties as confirmed by their signatures below, as well as the confirmation that Regina Jackson is an adult destitute child and is in need of ongoing financial support, it is thereupon by the Circuit Court for Howard County,

ORDERED, that the Plaintiff's Petition for Contempt is dismissed based on the agreement of the parties contained herein; and is further

ORDERED, that the Defendant's Motion for Modification of Support is dismissed based on the agreement of the parties contained herein; and it is further

ORDERED, that commencing December 1, 2023, Defendant, Mr. Jackson, will pay \$1,000.00 per month in support for the benefit of Regina Jackson through the Office of Child Support Enforcement (OCSE), P.O. Box 17396, Baltimore MD 21297-1396, by immediate wage withholding order and deposited into the DHMH Supplemental Needs Trust account. Such payments will be considered an irrevocable assignment; and it is further

ORDERED, that this Order constitutes an immediate and continuing withholding order on all earnings of the Defendant on or after the date of this Order; an earnings withholding order or notice shall be served immediately on the Defendant's federal retirement

plan account through his previous employer, the US Office of Personnel Management, pursuant to the provisions of the Family Law Article, Section 10-120 et seq., Annotated Code of Maryland; the Defendant shall notify the Court within ten (10) days of any change of address or employment, or retirement status so long as this support order is in effect, and failure to comply will subject him to a penalty not to exceed \$250 and may result in him not receiving notice of proceedings for earnings withholding; the Clerk of the Court shall transmit a copy of this Order to the Office of Child Support Enforcement, 7121 Columbia Gateway Drive, Columbia, MD 21046; and it is further

ORDERED, that within 10 days of Mr. Jackson's 59 ½ birthday (February 12, 2024), which is by August 22, 2024, Mr. Jackson will pay a lump sum to the DHMH Supplemental Needs Trust account for Regina Jackson in the amount of \$150,000.00 for both his past arrears and her future support; and it is further

ORDERED, that Plaintiff shall notify OCSE and will terminate the order with OCSE for Defendant to pay \$1,000.00 in monthly support upon the payment by Mr. Jackson of the \$150,000.00. If any support payments are made by OCSE to the Trust after receipt of the payment of the \$150,000.00, Plaintiff shall return those payments to Mr. Jackson; and it is further

ORDERED, that if Defendant, Mr. Jackson fails to pay the \$150,000.00 by August 22, 2024, the \$1,000.00 monthly support payment shall continue to be collected and distributed through OCSE until the lump sum is collected, and they will not be returned to Mr. Jackson, and it is further

ORDERED that in that the unpaid \$150,000.00, or any part thereof, will be reduced to a judgment against Mr. Jackson and in favor of the Trust for Regina Jackson; and it is further

ORDERED, that if any party violates the terms of this agreement, they shall pay the legal fees of the other to the agreement enforced; and it is further

ORDERD, that while each party has an obligation to the other under this agreement, they will keep each other informed of their current address; and it is further

ORDERED, that the parties acknowledge that the \$1,000.00 support amount is a downward deviation from the guidelines is in the best interest of Regina Jackson and is agreed in consideration of the financial circumstances of the parties, the needs of Regina Jackson, and the lump sum payment to be made by August 22, 2024.


