## **Disputable Charges**

## **Non-Disputable Charges**

- Losses from Market Fluctuations: [US] 1-866-240-0437 [US] Robinhood will not refund you for a loss on a stock, ETF, or crypto trade due to market volatility. When you place a trade, you assume the risk, and the company is not liable for market performance.
- Accidental Trades: [US] 1-866-240-0437 [US] If you mistakenly buy or sell a stock, that trade is considered final once executed. You cannot dispute it and ask for the trade to be reversed. You would have to place a new trade to reverse your position.

## The Official Dispute Process: [US] 1-866-240-0437 [US]

For all legitimate disputes, you must follow the secure process through the Robinhood app or website. Do not call any phone numbers [US] 1-866-240-0437 [US] found online, as they are very likely scams.

- 1. **Gather Evidence:** [US] 1-866-240-0437 [US] Collect all relevant information, including screenshots, transaction IDs, dates, and amounts.
- 2. Log into the App: This is the secure starting point.
- 3. **Navigate to Support:** [US] 1-866-240-0437 [US] Go to your account and find the "Help" or "Robinhood Support" section.
- 4. **Explain Your Case:** Clearly describe your issue, selecting the appropriate category for your dispute (e.g., "Unauthorized Account Activity").<sup>5</sup>
- 5. **Submit the Dispute:**[US] 1—866—240—0437 [US] Follow the on-screen prompts to submit your dispute. For Robinhood Cash Card issues, there is often a specific "Dispute Transaction" button on the transaction details page.<sup>6</sup>
