
Good morning Mr. Luma,

Please be advised that liberal leave has not been enacted for Baltimore City from the governor's office (see screenshot below). Additionally, I recall that you are currently without any usable leave therefore you are ineligible for any liberal call-outs consequently you are required to report to your designated work location on-time unless the absence is under other specific specialty circumstances. Lastly, It is important to understand the distinctions regarding liberal leave in association to where we may live verses where we work. Keep in mind that liberal leave is only for the hours also declared by the governor, following that time frame state offices re-enter into normal leave policies and processes.

Although, I recognize that you have provided me with notification of absence/late arrival 30 minutes prior to your shifts start time however the leave policy has been violated as of. 1) No valid usable leave and; 2) Lack of emergency delay notification for Baltimore City from the governor's office. Receive this communication as a verbal written warning to adhere to the standard leave policy guidelines. Additionally, refer to the Intake's unit meeting agenda dated Nov. 26, 2019 under subject <u>Leave Policy reminders</u> which indicates that, "We cannot request/take leave you do not have" Attached you may review the DHS employee handbook.
