CONSENT ORDER

This matter having come before the Circuit Court for Calvert County, Maryland on the January 16, 2019, the parties having reached an agreement on all matters without the necessity of a hearing, it is therefore, on this _____ 8th of February, 2019 _____, be and hereby,

ORDERED, that the parties herein expressly consent to the terms of this Order; and it is further,

ORDERED, that residential custody of the subject minor child, ALENA DALY, is hereby granted unto to the Plaintiffs RONNIE SCOTT and YVONNE SCOTT; and it is further

ORDERED, that shared legal custody of the minor child is granted to the Plaintiffs, Ronnie Scott and Yvonne Scott, and the Defendants, Donald Daly and Laura Puffenbarger; and it is further,

ORDERED, that Defendant, Donald Daly, will have the following visitation schedule with the minor child:

- A. That Defendant will have make-up weekend visitation with the minor child from January 18, 2019 at 6:00 P.M. through January 20, 2019 at 6:00 P.M., and January 25, 2019 at 6:00 P.M. to January 27, 2019 at 6:00 P.M, that will supersede the regular visitation schedule.

- B. That Defendant will have every other weekend from Friday evenings at 6:00 P.M. through Sunday at 6:00 P.M. until the minor child starts school on September 3, 2019.
- C. That all weekend exchanges will have the Defendant picking up the minor child at the Co-Plaintiffs' residence on Fridays, and the Co-Plaintiffs will pick up the minor child from the Defendant's residence on Sundays until the minor child starts school in September 2019.
- D. That after the minor child begins school in September 2019, Defendant's weekends will be every other weekend from Friday at 6:00 P.M. through Monday morning, dropping off the minor child at her school.
- E. That if a federal holiday falls on Defendant's weekend, then Defendant's weekend will be extended from Fridays at 6:00 P.M. through Tuesday morning, dropping off the minor child at her school.
- F. That all overnight exchanges with the exception of Monday morning drop offs, after the minor child begins school on September 3, 2019, will be conducted at the Home Depot in Upper Marlboro, Maryland.
- G. That on weeks that Defendant does not have weekend visitation, Defendant will have a Wednesday visitation between 5:00 P.M. and 7:00 P.M. with the minor child, and Defendant will be responsible for pick up and drop offs of the minor child.
- H. That Defendant is to have two (2) non-consecutive weeks in the summer of 2019.
- I. That Defendant is to have four (4) non-consecutive weeks in the summer of 2020, and all proceeding summers.
- J. That Defendant's notice for his weeks in the summer will be provided to Co-Plaintiffs by May 15th of each year. In the event of a dispute for preference of summer visitation weeks, Defendant will have tie-breaking preference for summer week vacation preference on odd years, and Co-Plaintiffs will have tie-breaking preference for summer week vacation preference on even years.
- K. That the parties will have the following holiday schedule:

- a. That the Thanksgiving holiday shall be defined as the Wednesday preceding the holiday, after school, through the Sunday following the holiday at 6:00 P.M. That the Defendant will have the Thanksgiving on even years, and the Co-Plaintiffs will have the Thanksgiving holiday on odd years.
- b. That the Christmas holiday will be defined as part one (1) being Christmas Eve at 12:00 P.M. through Christmas Day at 12:00 P.M., and part two (2) being Christmas Day at 12:00 P.M. through December 26th at 12:00 P.M. That the Co-Plaintiffs will have part 1 on odd years, and Defendant will have part 2 on odd years. That Defendant shall have part 1 on even years, and Co-Plaintiffs shall have part 2 on even years.
- c. That the New Year's holiday will be defined as part one (1) being New Year's Eve at 12:00 P.M. through New Year's Day at 12:00 P.M., and part two (2) being New Year's Day at 12:00 P.M. through January 2nd at 12:00 P.M. That Defendant will have part 1 on odd years, and Co-Plaintiff's will have part 2 on odd years. That Co-Plaintiffs will have part 1 on even years, and Defendant will have part 2 on even years.
- d. That Spring Break will be split evenly between the parties. That the parties will rotate Easter Day with Defendant having visitation with the Minor Child on odd years, and Co-Plaintiffs having visitation with the minor child on even years.

ORDERED, that each party will provide forty-eight (48) hour notice of all medical and educational appointments for the minor child, to all other parties of this matter, outside of an emergency, in which the party that is taking the minor child to a medical appointment will provide notice as soon as possible; and it is further,

ORDERED, that no third parties are allowed to be present at any medical, educational and behavioral counseling appointments; and it is further,

ORDERED, that all parties of this matter are allowed to travel outside the State of Maryland with the minor child; and it is further,

ORDERED, that if any party is taking the child outside of the State of Maryland area, then that party will provide twenty-four (24) notice to all other members of this matter, as well as a good phone number for them to reach the minor child; and it is further,

ORDERED, that if the parties are unable to effectively communicate via text message, email or phone, then a telephone conference will be scheduled with Judge Wells or any other Circuit Court Judge for Calvert County, Maryland, if Judge Wells is no longer presiding as a Circuit Court Judge for Calvert County, Maryland to discuss whether the parties should communicate via Our Family Wizard; and it is further,

ORDERED, that Defendant be placed on the minor child's emergency contact list; and it is further,

ORDERED, that this matter is closed for statistical purposes.


